

# **Managing Pain During an Opioid Epidemic**

Resources for nurses, patients, and the public.

hronic pain and opioid use disorder are complex, intersecting conditions that affect millions of Americans and result in untold disability, loss of function, and even death. Over the past two decades, opioid overdose deaths have risen sharply in tandem with increased prescribing of opioids for pain. Drug overdose, predominately involving opioids, is now the nation's leading cause of unintentional injury deaths. In October 2017, the U.S. Department of Health and Human Services (HHS) declared the opioid crisis a nationwide public health emergency.

Nurses—who have an ethical responsibility to relieve pain and the suffering it causes³—may face challenges and constraints when caring for people taking opioids. Given the national opioid crisis and the risks associated with these drugs, providing optimal pain relief can create a conflict for nurses between their duty to manage pain and their obligation to avoid causing harm.³ The following resources are available to help nurses address this challenge by increasing their knowledge—and to help educate patients, families, and the public on chronic pain relief and ways to combat the opioid epidemic.
